



WUSM Neuroscience Building Project COVID-19 Safety Plan

McCarthy is committed to ensuring the health and well being of our employees and their families. The spread of COVID-19 has become a significant public health concern; that's why we are taking precautions to protect employees, the public around our projects, and the many third parties we interact with each day. This means demonstrating healthy hygiene practices, maintaining a safe work environment, and safeguarding the continuity of our business operations.

Healthy personal hygiene practices, such as handwashing, social distancing, and staying home when sick, are important steps employees can take to prevent the spread of infectious diseases. Maintaining a healthy work site is just as important. Project supervision should take the following steps to help reduce the risk

Planning & Communication

1. Project has developed a COVID-19 Site Specific Safety Plan that addresses the specific protective and mitigation measures applicable to their project.

Social Distancing

1. Maintain social distancing of 6' within office and jobsites whenever possible
2. McCarthy to adjust work schedules and add additional shifts, where possible and if needed, so workers can maintain social distancing of 6', where possible.
3. Limit Safety Meetings/THA Meetings to less than 10 people. Photograph or video record meetings and/or track attendance verbally to eliminate passing around clipboards or tablets for sign in.
4. If jobsite has personnel hoist/elevator, limit passengers to maintain social distancing requirements.
5. All in person meetings limited to those deemed essential and limit attendance to less than 10 people.
6. 1 person max (driver) in all McCarthy company trucks/vehicles.

Jobsite Cleaning & Disinfecting

1. Jobsite offices, trailers, break/lunchrooms will be cleaned at least once/day.
2. McCarthy will maintain disinfectant supplies such as alcohol solution with at least 60% alcohol and diluted household bleach solutions.

3. Hand washing stations placed throughout the project with soap and, if available, alcohol based hand sanitizer and/or wipes.
4. Frequently touched items (i.e. door pulls and toilet seats) will be disinfected often.
5. Implement and maintain our Keep it Clean Keep it Safe Housekeeping Program to reduce dust levels on the jobsite.

Prevention:

1. Wash your hands well, (20-30 seconds) and often, with soap and water.
2. Cover your mouth and nose with a tissue or your sleeve when coughing or sneezing.
3. Avoid touching your eyes, nose and mouth with unwashed hands.
4. Avoid close contact with sick people.
5. Clean and disinfect frequently touched objects and surfaces.

Jobsite Exposure Control

If someone at your project is believed to have been exposed to COVID-19, or demonstrates symptoms of the virus, that location must follow the actions below:

1. Remain Calm. It is important to avoid overreacting in order to prevent panic on the jobsite.
2. Report immediately to the following:
 - Human Resources Director
 - Safety Director
 - Legal
 - McCarthy VP of Operations
 - Project Director
3. Subject to other direction from those listed above, the individual should contact their local medical provider or their county health department hotline for further guidance. In addition, you should identify any other individuals who had prolonged contact too and within 6 ft. of that individual and send those individuals home until further notice.
